

ITC Conference Grants GP4 Call (2022/11/01 to 2022/12/20)

*Due to technical difficulties, the call has been extended until 20th December 2022

Conditions of application:

- ITC Conference Grants aim at supporting Young Investigators and Innovators (under 40 years of age) affiliated with an institution located in an Inclusiveness Target Country (ITC) or Near Neighbour Country and participating in the COST Action CA18205 "Worlds of Related Coercions in Work" (WORCK) to attend international scientific conferences organised not specifically by the COST Action. Beneficiaries will be able to present the Action, their activities, and results (oral presentation) in them.
- The applicant can request up to 900 € for in person conferences, and up to 500 € for online conferences.
- If funded, the applicant must use the Cost Action Logo and reference in their presentation or poster

Eligibility Criteria

- The applicant must be a member of the Action, under 40 years of age, and their primary affiliation is an institution located in an ITC or Near Neighbour Country (full list to be found here: https://www.cost.eu/uploads/2022/11/Annex-I-level-A-Country-and-Organisations-Table-Version-1.4.pdf).
- The applicant must give an oral or poster presentation at the conference in question, and must be listed in the official event program. The main subject of the presentation or talk must be on the topic of the COST Action and must acknowledge WORCK.
- ITC Conference Grants are applicable within the Action Grant Periods (GP). Conferences in the GP4 must take place between preferably at least 45 days after the end of the deadline for this Call for Applications and end before 15 October 2023 (fifteen days before the end of the GP).
- The applicant must be listed in the official conference program and present a poster or paper on a topic related to the COST Action's activities.
- Conference Grants only concern non COST activities (irrespective of their nature of conferences, seminars, workshops, etc.)



• The successful applicant will use the Cost Action Logo and reference in their presentation or poster.

Application Procedure

Applications are to be submitted through the e-COST platform (https://e-services.cost.eu/activity/grants) and will be evaluated by the Grant Awarding Coordinator and a Committee. Priority will be given to the applicants who have not enjoyed the grant before. They must upload the following documents:

- 1. Filled in ITC Conference Grant application form. A template is downloadable here: <u>ITC</u> <u>Conference Grant Application Form</u> (Word)
- 2. The applicant's CV, including recent publications (max. 1 page)
- 3. An acceptance letter from the conference organisers (confirming either the applicant's speaking slot or poster presentation)
- 4. Copy of the abstract of the accepted oral or poster presentation
- 5. Acceptance letter from the conference organisers
